





Introduction



To get you started with your upgrade, we've detailed some key steps to ensure you have a smooth transition...






Step 1: We'll let you know when you're eligible to upgrade



You can find the Terms and Conditions once you log into Partner Edition.


Once you're able to upgrade, we'll let you know both in Partner Edition and via email. To move forward, we need you to accept the new terms and conditions.



When you log in, you'll see the above pop-up.




Step 2: Accept the new Terms and Conditions

Don't worry—we'll do all the hard work in the background! In the meantime, you can carry on using Partner Edition like always.




Step 3: Plan and prepare






Step 4: Get—and note —your upgrade date




Step 5: It's your upgrade day
